October 15, 2014/Meeting Minutes

Call to Order: President Larry Courcelle called the meeting to order at 5:15 p.m.

We ended up with a \$16,000 gain. In addition, we received a \$200,000 bequest and recorded unrealized gains of \$81,000, for an overall gain of \$341,000. Kay Jones moved to approve the report, and Dave Cooper seconded the motion. Approved.

President's Report: Larry Courcelle thanked everyone on the board for their support these past two years. He thanked Randal Smathers for stepping in on the Building Committee. He thanked the staff and the Friends of the Library. In recognizing Paula Baker's retirement he thanked Joan Gamble for heading up the search committee and remarked that it was a great process and experience. He was pleased to be the one to personally call Abby Noland and offer her the job. The space study is coming along well and work will continue in the upcoming year.

Director's Report: Abby Noland thanked the board for hiring her. The staff of the library are working together to bring this community the best services possible. They are moving forward as a team to increase children's programming, collaborate for more adult programming, develop patron friendly technologies, and carry forward the strategic plan. Abby ended by saying that she has found herself surrounded by dedicated, customer-service oriented, community minded and very intelligent Staff, Friends and Trustees. She ended with a quote from Michael Jordan. "Talent wins games, but teamwork and intelligence wins championships."
